

THIS SITE USAGE AGREEMENT is made effective as of this 20th day of August, 2011, by and between GiottosLibrary, a dba of AthanorBooks, LLC Inc. (hereinafter sometimes referred to as the "Company"), and (hereinafter referred to as "you" or "the Member").

The Company operates this Site to provide online searchable access to information about art, philosophy, religion, and topics related to those (the "Service").
